

**WARRANTY INFORMATION!** This affects your legal rights. **LIMITED WARRANTY POLICY**

Signal Collective LLC warrants all snowboards and products sold to be free of material and manufacturing defects for a period of one (1) year from original date of purchase. If a product is found to be a valid warranty claim by Signal Collective LLC, in its sole discretion Signal Collective LLC's only responsibility shall be limited to repair or replacement of the defective product. Signal Collective will not be responsible for any incidental expenses including binding removal/remounting, stomp pads, stickers, etc. Signal Collective will not be responsible for any costs, losses, or damages incurred as a result of loss of use of the product.

- 1) The warranty only applies to products made by Signal Collective and purchased from authorized dealers, and is valid to the original purchaser only, and is not transferable.
- 2) The warranty registration card must be filled out and mailed to Signal Collective within ten(10) days of purchase.
- 3) This warranty does not apply to:
  - a) Damage cause by misuse, abuse, accident, and neglect.
  - b) Damage caused by improper mounting and adjustments of bindings.
  - c) Normal wear and tear.
  - d) Damage caused by anything other than defects in materials or workmanship.
  - e) Impact related damage (such as rails, boxes, rocks, urban assault riding, etc.)
  - f) Intentional acts resulting in overstressing and destruction of product.
  - g) Damage caused by use of solvents or thread locking adhesives.
  - h) Board modifications or repairs.
- 4) We attempt to replace with products, which are identical, but under some circumstances we may replace with a reasonable equivalent.
- 5) Damage Products must be returned within a reasonable period of time after incurred damage.
- 6) The repaired board or replacement will be returned at our expense. If we determine that there is no defect present, or damage is not under warranty, return of product is at your expense.
- 7) Signal Collective assumes no responsibility for products furring shipment from the customer to the factory. Shipping charges are nonrefundable.
- 8) Repaired or replaced products are covered for the remainder of the original warranty only.

- 1. RELEASE AND WAIVER OF CLAIMS AGREEMENT. In consideration of the sale to you, or use by you, of the enclosed snowboard equipment, you hereby agree as follows. If you do not agree with the terms of the agreement, please return the equipment, unopened, to your retailer for a refund:
- 2. ASSUMPTION OF RISK/WARNING. I am aware that snowboarding involves certain inherent risks, dangers and hazards which can result in serious injury or death. I am also aware that snowboard boot/binding systems are not designed or intended to release. I hereby agree to assume and accept any and all known and unknown risks or injury while using the equipment. I further recognize and acknowledge that the risks inherent in the sport of snowboarding can be greatly reduced by taking lessons, riding within my abilities and using common sense at all times.
- 3. WARRANTY DISCLAIMER. EXCEPT AS SPECIFICALLY SET FORTH IN PARAGRAPH 9, THE EQUIPMENT IS SOLD AS-IS WITHOUT ANY WARRANTY OF ANY KIND, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. YOU AGREE TO INDEMNIFY AND HOLD SIGNAL COLLECTIVE LLC AND ITS SUPPLIERS AND RETAILERS HARMLESS AGAINST ANY CLAIMS BY THIRD PARTIES RELATED TO THEIR USE OF THIS SNOWBOARD;
- 4. WAIVER. YOU HEREBY WAIVE ALL CLAIMS THAT YOU CURRENTLY HAVE, OR MAY HAVE IN THE FUTURE AGAINST SIGNAL COLLECTIVE LLC AND ITS SUPPLIERS AND RETAILERS RELATED IN ANY WAY TO YOUR USE OF THE EQUIPMENT;
- 5. RELEASE. YOU HEREBY RELEASE SIGNAL COLLECTIVE LLC AND ITS SUPPLIERS AND RETAILERS FROM any and all liability for any loss, damage injury or expense that you may suffer, or that your kin may suffer. As a result of the use of this equipment, due to any cause whatsoever, including negligence or breach of contract on the part of SIGNAL COLLECTIVE LLC OR ITS SUPPLIERS OR RETAILERS in the design, manufacturer, selection, installation, maintenance or adjustment of the equipment.
- 6. ARBITRATION: In further consideration of the sale to or use by you of the equipment, you hereby agree to submit to binding arbitration any and all claims which you believe you may have against SIGNAL COLLECTIVE LLC and/or its suppliers or retailers arising from any use of the equipment. The arbitration shall be pursuant to the rules of the American Arbitration Association. The submission to the American Arbitration Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction. Arbitration shall be commenced within one (1) year from the date on which any alleged claim first arose. Further, the arbitration shall be held in Huntington Beach, CA unless otherwise mutually agreed to by all parties. Any claims, whether in contract or tort, related to this agreement or any use of the equipment shall be governed by the laws of the state of Washington without regard to any conflict of laws provisions, and any claims related to this agreement and/or the equipment brought hereunder shall except for arbitration set forth above, be brought in federal or state court in Seattle, Washington.
- 7. BINDING EFFECT OF AGREEMENT: In the event of your death or incapacity, this agreement shall be effective and binding upon your heirs, next of kin, executors, administrators, assigns and representatives.
- 8. ENTIRE AGREEMENT: In entering into this agreement, you are not relying upon any oral or written representations other than what is set forth in this agreement.
- 9. CONTINGENT LIMITED WARRANTY. Contingent upon you (or your parent) signing and returning this agreement to Signal Collective, along with a copy of your receipt, within fourteen (14) days from the date of purchase, Signal Collective LLC thereby grants you the limited warranty contained on the top of this card. Your failure to sign and return this agreement shall not affect the enforceability of this agreement, only the application of the limited warranty.
